I am announcing my decision to retire from my position as Chief Executive Officer (CEO) of Camp Fire Snohomish County. My resignation will become effective on January 28, 2022.

Being involved in delivering the mission of Camp Fire and having opportunities to directly serve youth and families within the Camp Fire network has been an experience I have and will continue to cherish. At the same time, I look forward to the future adventures life has to offer my family and me.

I have met with and communicated my plans with Board President Krissy Davis and the Executive Board as well as National Camp Fire President and CEO Greg Zweber. I have also met directly with my leadership team here internally. We have developed a communication plan to make all of our volunteers, donors and other constituents aware of the transition.
